TOILET REBATE POLICIES

Duplex/Triplex/Apartment Complex



The Toilet Rebate program is available to all Tucson Water customers who currently have a toilet that was manufactured prior to 1991 and uses 3.5 gallons per flush or more. Customers must meet the following standards in order to qualify for the Rebate program:

- Only fixtures purchased after July 7, 2008 qualify for a rebate.
- Toilets must be installed on properties receiving water from Tucson Water.
- Rebate amount is limited to 50% of purchase price with a maximum of \$100 per toilet. The rebate covers only the purchase cost of the tank and bowl, and does not include tax or additional supplies.
- **CONTACT TUCSON WATER AT (520) 791-4331 TO VERIFY ELIGIBILITY BEFORE PURCHASING A TOILET.**
- Only High Efficiency Toilet (HET) fixtures approved by the USEPA WaterSense program qualify for rebate. An HET fixture uses 1.3 gallons per flush or less. Please check the list of approved toilets on this USEPA website: www.epa.gov/watersense/pp/find-het.htm
- Rebates are provided to encourage the voluntary early replacement of older, less efficient pre-1991 toilets. Fixtures replaced as part of a general construction permit (such as a house remodeling) do not qualify for rebate.
- Fixture must replace a 3.5 gallon per flush or greater volume toilet.
- Old toilet fixtures must not be used again, and must be rendered inoperable.
- Participants in the rebate program must consent to an inspection of the property to verify purchase and installation of fixture.
