The internship program is an intensive two-week course that introduces middle school and high school teachers to the water management issues facing the community and provides opportunities to interact with the utility in an education setting. The internship is designed to provide teachers from all curriculum areas with relevant information. Graduates will develop water related projects in their classrooms in the 2005-2006 school year.

INTERNS WILL RECEIVE:

- ◆ Up to \$750 dollars for the completion of the two-week internship and follow-up
- ◆ The potential for professional development credit
- ◆ Excellent resources/information to bring to their students
- ◆ Continued access to Tucson Water experts following the internship
- ◆ Project WET Workshop Handbooks
